

MyTax.DC.gov User Guide:

How to Submit a Voluntary Disclosure Agreement Request

The District of Columbia Office of Tax and Revenue (OTR) encourages businesses and individuals that are not in compliance with the District tax laws to come forward voluntarily to bring their account(s) into compliance. If a taxpayer has failed to pay District taxes by not reporting income or transactions, he/she may contact OTR to make satisfactory arrangements to clear their tax record by submitting a Voluntary Disclosure Agreement (VDA) Request via <u>MyTax.DC.gov</u>.

Learn how to submit a Voluntary Disclosure Agreement (VDA) Request via <u>MyTax.DC.gov</u> by following this step-by-step guide:

MyTax.DC.gov User Guide: How to Submit a Voluntary Disclosure Request

- Under the Voluntary Disclosure Agreement (VDA) Request, select the Account Type (e.g. Unincorporated Business Franchise Tax, Ballpark Fee, etc.) in which you are disclosing the unpaid liability. For Unincorporated Business and Corporate Franchise Tax, enter <u>your</u> Current Taxable Year End Date and the appropriate Filing Frequency will populate.
 - a. When selecting Sales & Use Tax, three questions will populate (Reporting DC Sales Tax as a remote seller, Reporting DC Sales Tax as a marketplace facilitator, and Is your location part of a TIF). Your responses will determine the filing frequency that will auto populate. Select the **Filing Period From** and **Filing Period To**.
- 3. Click Next.

MyTax.DC.gov User Guide: How to Associate a MyTax.DC.gov account to a VDA Request Case

Upon the Office of Tax and Revenue's approval of your Voluntary Disclosure Agreement Request, you will receive a *Voluntary Disclosure – Registration/Filing Returns* letter by U.S. Postal mail or email (which ever you provided in your submission). This letter will contain the **Confirmation Number** that is required to associate your <u>MyTax.DC.gov</u> account to the VDA case. Additionally, the letter will require you to register via <u>MyTax.DC.gov</u> before associating the account to the case.

Note: Please contact the VDA Team at <u>vda@dc.gov</u> if you do not have the *Voluntary Disclosure* – *Registration/Filing Returns* letter or Confirmation Number.

- 1. From the <u>MyTax.DC.gov</u> homepage, log in using your **Username** and **Password**.
 - a. If you do not have a <u>MyTax.DC.gov</u> account, click **Sign-up for MyTax.DC.gov** to register for an account. (click <u>here</u> to access the "How to Sign up for MyTax.DC.gov" user guide).

MyTax.DC.gov User Guide: How to Electronically Sign your Voluntary Disclosure Agreement

Once the Voluntary Disclosure Agreement Team has reviewed and processed the Voluntary Disclosure Agreement Request case, the final step will be to electronically sign the Voluntary Disclosure Agreement. You will receive an email notification that states the agreement is ready for signature.

Learn how to electronically sign your Voluntary Disclosure Agreement (VDA) via <u>MyTax.DC.gov</u> by following this step-by-step guide:



1. Log In to you MyTax.DC.gov account.

2. In the user profile, under the **Summary Tab**, click **View Other Options** for the account type associated with the Voluntary Disclosure Agreement Request case.





3. Under the Account Management section, click Voluntary Disclosure Case Signature.



- 4. The **Voluntary Disclosure Agreement** will appear. Read the agreement in its entirety. At the bottom, **Signing As** (your name) is prefilled and you need to select your **Title**.
