## Filing a Cigarette Wholesaler Monthly Report (FR-467)

- 1. From the MyTax.DC.gov homepage, log in using your Username and Password.
  - a. If you do not have a <u>MyTax.DC.gov</u> account, click **Sign-up to use MyTax.DC.gov** to register for an account (click <u>here</u> to access the "How to Sign up for MyTax.DC.gov" user guide).
