

## MyTax.DC.gov User Guide: How to Take an Identity Quiz

To help combat identity theft and tax fraud, the Office of Tax and Revenue (OTR) requires additional verification for selected tax returns. Learn how to respond to your Notice of Identity Confirmation via <u>MyTax.DC.gov</u> by following this step-by-step guide.

1. From the <u>MyTax.DC.gov</u> homepage, under **INDIVIDUAL**, click the **Respond to Verification Letter** hyperlink.



2. On the Respond to Verification Letter landing page, click the **Take an Identity Quiz** hyperlink to submit your response.

- 4. Enter and re-enter the last 4 digits of the Primary Filers SSN/ITIN.
- 5. Select **Yes** if you filed the return yourself **or** select **Yes** if you authorized someone else to file your tax return on your behalf.
- 6. Enter the **refund amount** on the return for the tax year on the notice. If you are not requesting a refund, enter zero.
- 7. Click Submit.
