Instructions for FP-110 Application for Tax Deferral For Low-Income Senior Property Owners and Low-Income Property Owners

You may be eligible for the Tax Deferral Program for Low-Income Senior Property Owners or Low-Income Property Owners. The Low-Income Senior Tax Deferral Program permits eligible low-income seniors to defer all real property taxes owed, currently, prospectively and retroactively. The Low-Income Tax Deferral Program permits eligible low-income owners to annually defer the increase over the prior year's real property taxes.

The deferral will apply to the first tax year indicated and succeeding tax years thereafter. You are responsible for any tax sale expenses, including legal fees; such expenses are not deferred.

Then review and select the Deferral plan you are applying for: Deferral Program Requirements

To apply for the **6% Senior Deferral**, you must: (1) be a District domiciliary; (2) own at least 50% of a house or condominium (with no more than 5 dwelling units therein) in the District; (3) the house or condominium must be your principal place of residence; (4) be 65 years of age or older; (5) your household Federal Adjusted Gross Income (AGI) must be less than \$50,000 (aggregate income of all persons residing in household, excluding tenants with fair market value leases); and, (6) file this application for deferral.

To qualify for the **0% Senior Deferral**, you must: (1) qualify for the low-income senior tax deferral program at 6%; (2) be at least 75 years old; (3) for the last 25 years have been domiciled and owning a principal place of residence in the District; (4) have household interest and dividend income less than \$12,500; and (5) file this application for deferral.

To apply for the **Non-Senior Deferral**, you must: (1) be a District resident living in a house or condominium that you own; (2) the household Federal Adjusted Gross Income (AGI) must be less than \$50,000 (aggregate income of all persons residing in household, excluding tenants with written fair market value leases); (3) file this application for deferral.
